Designing Wood Frame Buildings

The PHRC has scheduled two hands-on program on "Wood Frame Design for Buildings (NDS-97 Based)". Each program provides an overview of the basic design principles as well as opportunities to take part in problem-solving activities. It is intended for design professionals (architects and engineers), engineering staff from modular and manufactured housing, and building code officials.

Most model building codes are of limited applicability to wood frame construction. Any deviation from a simple design, such as cantilevers, goes beyond the scope of the code and references the ANSI/AF & PA National Design Specification (NDS) 1997 for Wood Frame Construction. This program is even more relevant as the Commonwealth of Pennsylvania moves toward adopting a statewide building code. The program was first given earlier this year in State College. Because it was very well received, we have decided to repeat it on:

Moisture Control Workshop

About 48 people—builders, developers, architects, educators—attended a one day workshop on Moisture Control in Buildings in Valley Forge on November 8th. This workshop consisted of a series of alternating presentations by Eric Burnett of Penn State and John Straube from the University of Waterloo in Canada.

The program before lunch was devoted to Building Science, i.e., the basic principles involved in the control of not only moisture but also heat and air into, within, across and out of the building enclosure. The afternoon sessions were directed at the performance of the enclosure components, i.e., roof systems and walls above and below grade.

The participants in the workshop were very attentive and the question and answers sessions were lively. Based on both questionnaires and individual comments, the workshop was very well received. It is likely that this workshop will be repeated probably in May 2002 in Harrisburg. Some architects and designers were interested in a workshop that was more technical and more focused on their needs. If there is enough interest in a more technical moisture control workshop, we would willingly provide one. Please let us know.

Training, Education and Development Specialist

The **Pennsylvania Housing Research Center** at The Pennsylvania State University invites applications for a new position as **Training, Education, and Development Specialist.** The position will be responsible for providing leadership and direction for the development, implementation and management of technical training programs for builders, remodelers, design professionals and building code officials. Topics may include residential and commercial building codes, energy efficiency, alternative building systems and housing technology and applied building science.

This position will also identify opportunities and develop proposals for funding of training programs, and assist in the management, implementation and administration of contracts. Additional responsibilities include writing technical reports and correspondence, serving as liaison with state and federal agencies, trade and professional associations, and individuals associated with the construction industry.

Work Related Experience: Construction related experience and building code enforcement experience; strong communications skills are required.

Interested applicants should submit a resume, a statement of interest, and the names of three references to the PHRC, Box A, 219 Sackett Building, University Park, PA. Applications will be considered until the position is filled. Review of applications will begin December 17.

Director: Factory Built Housing Programs

The Director will work closely with the Factory Built clients of the Pennsylvania Housing Research/ Resource Center. This person will be responsible for all the factory built housing initiatives involving the PHRC at Penn State and at Penn College. The responsibilities are to provide assistance in industry research and development, publish reports and data, and address industryrelated problems. Minimum qualifications include a Bachelor Degree in Construction and Design Technologies or a related discipline, or an equivalent combination of education and experience in management and education; five or more years of production, technical, or operations management experience within the factory built housing industry; and experience in the management of federal programs and with residential construction principles and building methods. Nationwide and statewide travel will be required.
